N-64 - L28B

NH-HSIP-275-7(207); C.N. 22843

Identified as **N-64 – L28B**, the proposed project would improve approximately 5.99 miles of U.S. Highway 275 (US-275) and approximately 1.48 miles of Nebraska Link 28B (L-28B) located in Douglas County.

The project portion on US-275 would begin about 0.50 miles south of the grade separation under Nebraska Highway 64 (N-64), at mile marker (MM) 163.55, and would extend south to the pavement transition from concrete to asphalt, at MM 169.02. The L-28B portion would begin at MM 0.00 and extend east to MM 1.48. Construction may begin and/or end approximately 500 feet ahead of or beyond the actual project limits to accommodate transitioning the pavement.

The purpose of the proposed project is to reduce the frequency and severity of crashes, improve the reliability of the transportation system and perpetuate the mobility of the traveling public. The need for the proposed project is based on the current condition of the roadway.

Proposed improvements would consist of concrete pavement repair, crack and joint sealing, removal and reinstallation of a high friction surface course, and milling and resurfacing the shoulders with asphalt.

The proposed project would not require the acquisition of additional property rights. No wetland and/or other water resource impacts are anticipated.

Construction is tentatively scheduled to begin in spring 2025, with anticipated completion by winter 2025.

The proposed project would be constructed under traffic with lane closures controlled by appropriate traffic control devices and practices; however, temporary overnight ramp closures would be required. Alternate routes would need to be utilized during these short-term closures. Lane and ramp closures would be avoided during the Junkstock festival.

The following ramps would be closed at varying times throughout construction, not all at once.

- US-275 northbound and southbound on/off ramps at Meigs Street
- N-64 westbound on-ramp to northbound US-275
- US-275 southbound off-ramp to eastbound N-64
- US-275 northbound and southbound on/off ramps at Blondo Street
- US-275 southbound off-ramp to West Dodge Road
- US-275 northbound on-ramp to northbound US-275
- US-275 northbound on-ramp to eastbound L-28B
- West Dodge Road eastbound on-ramp to eastbound L-28B
- L-28B westbound off-ramp to westbound West Dodge Road
- L-28B westbound and eastbound on/off ramps at 228th Street

NDOT has worked to develop this project to minimize inconvenience and hardships. We are dedicated to improving Nebraska's highway system and with your help we can achieve this goal.


