US-34 to I-80, Omaha

NH-75-2(188); C.N. 22859

Identified as *US-34 to I-80, Omaha*, the proposed project would improve approximately 8.07 miles of U.S. Highway 75 (US-75) located in Sarpy and Douglas counties.

The proposed project would begin about 0.4 miles north of the grade separation under U.S. Highway 34 (US-34) at approximately mile marker (MM) 78.26. The southbound section extends north to 0.2 miles north of the grade separation over Chandler Road, and the northbound section extends north to 0.3 miles south of the grade separation under Q street, at approximately MM 86.33. Construction may begin and/or end approximately 500 feet ahead of or beyond the actual project limits to accommodate transitioning the pavement.

The purpose of the proposed project is to preserve the transportation asset, improve the reliability of the transportation system and perpetuate the mobility of the traveling public. The need for the proposed project is based on the current condition of the existing roadway.

The proposed improvements on this project consist of concrete diamond grinding, crack and joint sealing, and concrete pavement repair.

The proposed project would not require the acquisition of additional property rights. Access to adjacent properties would be maintained but may be limited at times due to phasing requirements. No wetland and/or other water resource impacts are anticipated.

Construction is tentatively scheduled to begin in late fall 2024, with anticipated completion in spring 2025.

The proposed project would be constructed primarily under traffic with lane closures controlled by appropriate traffic control devices and practices; however, temporary overnight ramp closures would be required. Alternate routes would need to be utilized during these short-term closures. All or most of the project work may be required to be accomplished at night.

NDOT has worked to develop this project to minimize inconvenience and hardships. We are dedicated to improving Nebraska's highway system and with your help we can achieve this goal.


