### **SCOPE OF WORK**

Proposed improvements on the I-480 Missouri River Bridge, Omaha project would consist of bridge repairs to Structure Number S480 00413, superstructure painting, adding a bridge drainage system, minor electrical repairs, and updating lighting. Proposed improvements on the 12th St -Missouri River Bridge Painting, Omaha project would consist of painting specific locations within the bridge.

# **PURPOSE & NEED**

The purpose of the proposed projects is to preserve the transportation asset, improve the reliability of the transportation system and perpetuate the mobility of the traveling public. The need for the projects is based on the current condition of the existing bridges.

## **RIGHT-OF-WAY &** POTENTIAL IMPACTS

The proposed projects would not require the acquisition of additional property rights. Access to adjacent properties would be maintained but may be limited at times due to phasing requirements. The Lewis & Clark Trail is located within the project area, but no impacts are anticipated. No wetland and/or other water resource impacts are anticipated.

# TRAFFIC ACCOMMODATIONS

The projects would be constructed primarily under traffic with lane closures controlled by appropriate traffic control devices and practices; however, work on both projects would require multiple extended closures of Exit 4 (westbound ramp to Dodge Street). A designated detour would be provided utilizing Exit 3 to 14th Street. The Iowa Riverfront Trail would be closed under I-480 for approximately 21 days to accommodate work. A designated detour would be provided utilizing the River Edge Services Road Trail.

The 12th St - Missouri River Bridge Painting, Omaha project would also require local traffic under I-480 to be detoured onto local roads or experience lane closures to accommodate work. Pedestrian traffic may be detoured to adjacent sidewalks or maintained with temporary protective covers.

In addition, the 12th St - Missouri River Bridge Painting, **Omaha** project would now require a detour at the eastbound (EB) 14th Street on-ramp; the detour route would utilize N 14th Street and Douglas Street (US-6). Two closures would also be required on 8th Street; detour routes would be provided for both closures, utilizing Capitol Avenue, S 10th Street and Farnam Street. The 8th Street closures would not occur at the same time.

## **ANTICIPATED SCHEDULE & COST**

Construction of the I-480 Missouri River Bridge, **Omaha** project is tentatively scheduled to begin in fall 2024, with anticipated completion by fall 2026.

The 12th St - Missouri River Bridge Painting, **Omaha** project is tentatively scheduled to begin in fall 2024, with anticipated completion by fall 2025. The estimated cost of each project is approximately \$9 million with funding derived from federal funding sources.



Identified as I-480 Missouri River Bridge, Omaha and 12th St - Missouri River Bridge Painting, Omaha, the and Pottawattamie County, Iowa.

## **PROJECT LOCATION**

The I-480 Missouri River Bridge, Omaha project would begin on I-480 at approximately mile marker (MM) 3.98 in Nebraska and would include the length of the Missouri River bridge to approximately MM 0.25 in Iowa. This project would include the full length of the bridge and 500 feet beyond both ends of the bridge.

The 12th St – Missouri River Bridge Painting, Omaha project would begin at an expansion pier west of 13th Street at approximately MM 3.35 and would continue east along I-480 to approximately MM 3.98, which is the west end of the Missouri River Bridge. Construction may begin and/or end approximately 500 feet ahead of or beyond the actual project limits to accommodate bridge work.






# proposed projects would improve approximately 1.0 mile of Interstate 480 (I-480) in Douglas County, Nebraska
