NOTICE OF HIGHWAY IMPROVEMENT PROJECT

Skyline Dr – 168th St, Omaha

NH-6-7(188); C.N. 22811

Identified as *Skyline Dr – 168th St, Omaha*, the proposed project would improve approximately 1.49 miles of Nebraska Link 28B (L-28B) and approximately 2.01 miles of U.S. Highway 6 (US-6) in Douglas County.

The proposed project would begin with the L-28B portion at approximately mile marker (MM) 1.68, just east of the Elkhorn River bridge, and extend east to approximately MM 3.17, at the junction of L-28B with US-6 and Nebraska Highway 31 (N-31).

The project would continue with the first US-6 portion at the same junction mentioned above, at approximately MM 356.93, and extend east to MM 358.47, about 0.53 miles west of the grade separation over 192nd Street. The second US-6 portion of the project would begin at MM 358.47, 0.43 miles west of the grade separation under 180th Street, and extend east to approximately MM 360.04, just east of the viaduct over the Union Pacific Railroad (UPRR). Construction may begin and/or end approximately 500 feet ahead of or beyond the actual project limits to accommodate transitioning the pavement.

The purpose of this proposed project is to preserve the transportation asset, improve the reliability of the transportation system and perpetuate the mobility of the traveling public. The need for the proposed project is based on the current condition of the existing roadway and bridges and to correct ongoing erosion issues.

Proposed improvements on the project would include bridge repairs, shoulder replacement, approach replacements, curb and flume installation, culvert work, removing and replacing impacted guardrail and lighting, grading, and erosion control. Additional work would include grading beyond the hinge point and overhead sign structure replacement. Work would occur on the following structures along the project:

- SL28B 00216 Skyline Bridge over L-28B
- S006 35693 L & R US-6 Bridge over 204th Street
- S006 35890 180th Street Bridge over US-6
- S006 35981 168th Street Bridge over US-6
- S006 35999 US-6 Bridge over UPRR

The proposed project would not require the acquisition of additional property rights. Access to adjacent properties would be maintained but may be limited at times due to phasing requirements. No wetland and/or other water resource impacts are anticipated.

SL28B 00216 and S006 35693 L&R are historic bridges; no adverse effects are anticipated. The Skyline Trail over SL28B 00216 would be closed for approximately 20 working days to facilitate work on the structure.

Construction of the proposed project is tentatively scheduled to begin in spring 2024 with anticipated completion by winter 2024.

The proposed project would be constructed primarily under traffic with lane closures controlled by appropriate traffic control devices and practices; however, temporary overnight closures during the week, as well as full weekend closures, would be required at the 180th Street and 168th Street bridges and ramps. Alternate routes would need to be utilized during these short-term closures. The 204th Street bridge and ramps would require lane closures. Work at adjacent interchanges would not occur at the same time.

NDOT has worked to develop this project to minimize inconvenience and hardships. We are dedicated to improving Nebraska's highway system and with your help we can achieve this goal.


