Fairbury West Bridge

NH-136-6(121); C.N. 13183

Identified as *Fairbury West Bridge* the proposed project would repair the structure over the Little Blue River (Structure Number S136 14931) on U.S. Highway 136 (US-136) located in Jefferson County.

The proposed project is located at approximately mile marker (MM) 149.31 on US-136, about 0.57 miles west of the city of Fairbury. Construction may begin and/or end approximately 600 feet ahead of or beyond the actual project limits to accommodate reconstruction of the existing roadway.

The purpose of this proposed project is to preserve the US-136 transportation asset, improve the reliability of the transportation system, and perpetuate the mobility of the traveling public. The need for this proposed project is based on the current condition of the bridge.

Proposed improvements on this project would include removing the existing deck and re-decking the structure. Approach slabs would be added at both ends of the bridge which would require remodeling of the abutments for turndowns, and remodeling of the wingwalls and the bridge rail. Additional work would include guardrail replacement with surfacing underneath the guardrail.

Wetland impacts are anticipated and would be mitigated as necessary.

Construction could begin as early as spring 2025 and could be completed by winter of 2025.

The proposed project would not require the acquisition of additional property rights. Access to adjacent properties would be maintained but may be limited at times due to phasing requirements.

The proposed project would be constructed under traffic with lane closures controlled by appropriate traffic control devices and practices.


